

- Be a Certified or licensed health professional or Masters/PHD, high school diploma with letter from administrator/copy of state regulation for their position.
- Complete an Alzheimer and dementia seminar by an approved NCCDP instructor such as this
  program with Certificate of Attendance.
- Must have three years' experience in a health care setting.
- The fee for certification is \$100 and is included by attending this WHCA/WiCAL training seminar.

### Objectives:

Upon completion of this program, participants will be able to:

- 1. Explain what dementia is and how to care for a person with dementia;
- 2. Identify common causes of aggressive, repetitive and sun downing behaviors;
- Describe behavior/care interventions that may be used to prevent or reduce difficult care situations;

- 5. Demonstrate new communication techniques; and
- 6. Discuss techniques to handle personal care.
