Return to Work

The spread of COVID-19 has led many organizations to implement **remote work** policies, ask potentially infected employees to self-quarantine, or suspend operations entirely. EMPLOYEE DATA	USE
Employee Exposure	Assess likelihood of employee infection, including via proximity to infected individuals
Daily Temperature Readouts	Identify COVID-19 symptoms, such as fever
Employee Travel	Uncover travel to COVID-19-impacted areas
Employee Awareness	Knowledge of proper hand washing protocol
Name, email address, physical address, etc.	Ability to link information to a specific individual
