
### **Superior Health Quality Alliance**

### **Quality Improvement Goals**

- Improve behavioral health outcomes, focusing on decreased opioid misuse
- Increase patient safety
- Increase chronic disease self-management (cardiac and vascular health, diabetes, slowing and preventing end stage renal disease (ESRD))
- Increase quality of care transitions
- Improve nursing home quality

### **Past Nursing Home QIO Successes**

- Reduction in antipsychotic medication use
- Composite Score (reduction)
  - UTI prevention
- Onboarding to the CDC's National Healthcare Safety Network (NHSN)
- Infection Prevention and Control
- QAPI





## **Improve Nursing Home Quality**

- Enroll 786 nursing homes in MI, MN, WI
- Enrollment List:
  - MI: 262
  - MN: 251
  - WI: 273
- Enrollment List:
  - Rural-Small: 583
  - "Low performers":163
  - Abuse: 40

## **Improve Nursing Home Quality**

- Improve the mean total quality score for all nursing homes
- Reduce the percentage of nursing homes with a total quality score less than 1132





### **Improve Nursing Home Quality**

- Reduce adverse drug events in nursing homes
- Reduce healthcare-acquired infections in nursing homes
- Reduce ED visits for short stay residents
- Reduce readmissions for short stay residents









## **Current Nursing Home Technical Assistance**

Weekly average of 38 instances of one-on-one technical assistance (TA) provided to nursing homes

- NHSN
- Infection Control
- Care Coordination
- Other

262 instances of TA since late April 2020





#### CMS Memo June 1, 2020

QSO-20-31-All: COVID-19 Survey Activities, CARES Act Funding, Enhanced Enforcement for Infection Control deficiencies, and Quality Improvement Activities in Nursing Home

 "Quality Improvement Organizations have been strategically refocused to assist nursing homes in combating COVID-19 through such efforts as education and training, creating action plans based on infection control problem areas and recommending steps to establish a strong infection control and surveillance program."

#### CMS Memo June 1, 2020

- "QIOs are being deployed to provide technical assistance to nursing homes, which includes a targeted focus on approximately 3,000 low performing nursing homes who have a history of infection control challenges.
- States may request QIO technical assistance specifically targeted to nursing homes that have experienced an outbreak.
- The QIOs help nursing homes identify what their greatest areas
  of infection control problems are, then create an action plan, and
  implement specific steps to establish a strong infection control
  and surveillance program in the nursing home."

### **QII Introduction**

- High Priority and systemic infection control issues
- Selection of homes is derived from various CMS and public data sources
- QIOs to provide targeted, focused technical assistance
- Participation is voluntary, however...
- Shared fate for QIOs and Nursing Homes

## **QII Specifics: Nursing home expectations**

- Complete the Superior Health QII Action Plan with CDC tool within 30 calendar days
- Provide a C-suite signature to pledge commitment
- Supply at a minimum a baseline and six data points
- Complete Superior Health and other applicable satisfaction surveys





## QII Specifics: Superior Health expectations

Provide technical assistance with the completion of the CDC ICAR Assessment and a comprehensive QII Action Plan

- Conduct RCA
- Identify intervention(s) and an implementation plan
- Set realistic goals
- · Align interventions and goals to other agencies
- Track and monitor progress
- Estimate cost of harm(s) avoided

- Healthcare Personnel and Resident Safety
- Surveillance and Disease Reporting
- Hand Hygiene (HH)
- Personal Protective Equipment (PPE)
- · Respiratory/Cough Etiquette
- Antibiotic Stewardship
- Injection Safety and Point of Care Testing
- Environmental Cleaning

#### **Themes**

Of the nine domains assessed in the QII ICAR, the following themes have emerged:

- Environmental cleaning
- Hand hygiene (HH)
- · Injection safety and point of care testing
- Personal Protective Equipment (PPE)





### **Approaches**

- Capitalize on other infection prevention and control assessments and improvement opportunities (avoid duplicating efforts)
- Utilize existing performance improvement activities
- Postpone QII if active COVID-19 is present in the nursing home and that is the preference
- Reduce provider burden
- Recognize other issues and concerns (non COVID-19)
